He also has 8 years of experience in manufacturing in process engineering and operations management. Dan has inspected thousands of residential and commercial properties over the years. He has a class A general contractor's certification and has estimated and managed over 1,200 projects to restore property damage from hail and wind, structural failures, installation defects, manufacture defects, water restoration and fire damage mitigation. These restorations involved a wide variety of scopes of work including but not limited to: structural repairs, framing, interior finish, roofing, siding, soffit, fascia, windows, decks, concrete, and coatings. During that time, Dan has specified, supervised and/or managed the installation of over 2,000 roofing and/or exterior projects and a significant number of structural reinforcement jobs and interior finishes. He is very familiar with the different types of exteriors along with their components and various installation methods.

Over the last 10 years Dan has trained multiple personnel in the inspection, estimating and installation of a wide variety of steep and low slope roof systems.
