

SUPPLEMENTAL CONDOMINIUM DECLARATION OF LORETTA BANNER

This Supplemental Declaration to the Condominium Declaration for Chamonix at Woodrun Condominiums, is made this 18th day of May, 1985 by Chamonix at Woodrun Partners, a Georgia general partnership.

1. Definitions.

1.1 Condominium Declaration. "Condominium Declaration" shall mean the Condominium Declaration for Chamonix at Woodrun Condominiums, Snowmass Village, Colorado dated February 4, 1985, and recorded February 8, 1985 in Book 481 at Page 109 of the records of the office of the Clerk and Recorder of Pitkin County, Colorado as amended and supplemented from time to time.

1.2 Declarant. "Declarant" shall mean Chamonix at Woodrun Partners, a Georgia general partnership.

1.3 Additional Units. Subject to the provisions of Section 2.1 of this Supplemental Declaration "additional units" shall mean such additional units located on the real property described on Exhibit "A," attached hereto together with all fixtures which are contained within the unfinished perimeter walls, floors and ceilings of such units in the buildings and improvements as shown on the Supplemental Condominium Map for Chamonix at Woodrun Condominiums to be filed of record, but not including any of structural components of the buildings, or the general common elements.

1.4 Terms Previously Defined. All terms defined in the Condominium Declaration shall have the same meaning as when used in this Supplemental Declaration, except to the extent such term is given a different meaning in this Supplemental Declaration.

2. Declaration.

2.1 Additional Units. There shall be seventeen (17) additional Units located on the real

property described on Exhibit "A" attached hereto, which are contained in the buildings and improvements depicted on the Supplemental Map of Chamonix at Woodrun Condominiums to be recorded in the office of the Clerk and Recorder of Pitkin County, Colorado. These Units shall be designated 1, 2, 3, 15, 17, 25, 26, 27, 34, 35, 36, 37, 44, 45, 46, 47, and 54 on the Supplemental Map to be recorded in the office of the Clerk and Recorder of Pitkin County, Colorado. Units 1, 2 and 3 shall be on site PMH (employee) Units located on the real property described on Exhibit "A" attached hereto, and as designated on the Supplemental Condominium Map. Designated on Exhibit "B" attached hereto is a schedule of all the Units in the property, as expanded herein, together with the ownership interests, expressed as a percentage, in the general common elements of Chamonix at Woodrun Condominiums.

2.2 Common Elements. All general and limited common elements, as designated on the Supplemental Condominium Map, are hereby subjected to the general Condominium Declaration and this Supplemental Declaration.

3. General. All provisions of the Condominium Declaration not specifically superseded by this Supplemental Declaration shall apply to the additional Units, and to all additional buildings and improvements located on the real property described on Exhibit "A" as designated on the Supplemental Condominium Map.

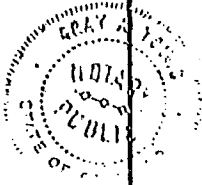
