- The Association is the entity created to manage the business and affairs of the B. owners of the property described in the Declaration and on the Map.
- C. Pursuant to Section 11.4 of the Declaration, the Declaration may be amended on written approval of 66.67% of the members of the Association.
- The Members of the Association desire to amend the Declaration to provide for the D. assignment of the right to future income including the right to receive common expense assessments.

Now, therefore, the Declaration is amended as follows.

- 1. Section 5.4 of the Declaration is amended by the addition of the following at the end of such section. "The Association shall have the power to assign its right to future income, including the right to receive common expense assessments."
- 2. All terms contained herein shall have the meaning ascribed to such terms in the Declaration. The provisions of this instrument shall be in addition to the provisions contained in the Declaration. In the event of any conflict between this First
